




RATING AND CHARACTERISTIC CURVES

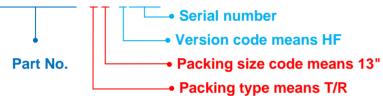
